

### **Terms and Conditions: 12 Days of Christmas**

This 12 Days of Christmas Giveaway (“**Giveaway**”) is held by Lucy Walker Jewellery PLT (“**Lucy Walker Jewellery**”). By entering this Giveaway, you will be bound by these Terms and Conditions.
